

WILLMORE WILDERNESS PARK

All that parcel or tract of land, situate, lying, and being in unsurveyed territory, west of the sixth (6) meridian, in the Province of Alberta Canada, and being within the boundaries more particularly described as follows:

Commencing at the intersection of the north boundary of Jasper National Park with the east boundary of township fifty-one (51), range three (3),

Thence north along the east boundary of the said range three (3), to the south east corner of township fifty-three (53), range three (3),

Thence east along the south boundary of township fifty-three (53) to the south east corner of township fifty-three (53), range two (2),

Thence north along the east boundary of the said township fifty-three (53), range two (2), to the north east corner thereof,

Thence west along the north boundary of the said township fifty-three (53), to the north east corner of township fifty-three (53), range three (3),

Thence north along the east boundary of the said range (3), to the north east corner of section one (1) of township fifty-four (54), range three (3),

Thence west along the north boundaries of sections one (1) to six (6) inclusive of the said township fifty-four (54), range three (3), to a point on the east boundary of township fifty-four (54), range four (4),

Thence north along the said east boundary of township fifty-four (54), range four (4), and continuing north along the east boundary of township fifty-five (55), range four (4), to the north boundary of the south half of the said township fifty-five (55), range four (4),

Thence west along the north boundary of the south halves of township fifty-five (55), range four (4), five (5), and six (6), to the east boundary of township fifty-five (55), range seven (7),

Thence north along the said east boundary of township fifty-five (55), range seven (7), to the north east corner thereof.

Thence west along the north boundary of the said township fifty-five (55), range seven (7), to its intersection with the east boundary of the westerly third of township fifty-six (56) range seven (7),

Thence northerly along the said east boundary to the south east corner of section twenty (20) in township fifty-six (56), range seven (7),

Thence westerly along the south boundaries of the said section twenty (20) and section nineteen (19) and continuing westerly along the south boundaries of the north halves of township fifty-six (56), ranges eight (8), nine (9) and ten (10) to the south east corner of section twenty-four (24) in township fifty-six (56), range eleven (11),

Thence northerly along the east boundaries of townships fifty-six (56), fifty-seven (57), and fifty-eight (58), range eleven (11) to tis intersection with the height of land between the Kakwa River to the north and the Smoky River to the south,

Thence westerly, southwesterly and northwesterly along the said height of land to its intersection with the Alberta-British Columbia boundary,

Thence southerly and southeasterly following the said Alberta-British Columbia boundary to its intersection with the boundary of Jasper National Park,

Thence northwesterly and easterly following the said boundary of Jasper National Park to the point of commencement.

The land herein described containing one thousand seven hundred and seventy-four and eight tenths (1774.8) square miles, more or less.
