## MIDLAND PROVINCIAL PARK

All those parcels or tracts of land, situate, lying, and being in the twenty-ninth (29) township, in the twentieth (20) range, west of the fourth (4) meridian, in the Province of Alberta, Canada, and being composed of:

- (A) The north half of section nine (9), the south half and north west quarter of section sixteen (16), the north half and south east quarter of section seventeen (17), all those portions of the north half of section eight (8), the south west quarter of the said section nine (9), and the south west quarter of the said section seventeen (17), lying generally to the north and east of the left bank of the Red Deer River, and all that portion of the north east quarter of section eighteen (18) of the said township, which lies to the south and east of the southeasterly limit of a surveyed roadway, as shown upon a plan of survey of record in the Land Titles Office at Calgary for the South Alberta Land Registration District as No. 831 0948, containing six hundred thirty-one and one hundred sixty-six thousandths (631.166) hectares (1559.59 acres), more or less.

### SAVING AND EXCEPTING:

- (1) Three and nine hundred seventy-five thousandths (3.975) hectares (9.82 acres), more or less, out of the said north half of section eight (8) required for a surveyed roadway and extra road, as shown upon a plan of survey of record in the said Land Titles Office as No. 841 1151.
- (2) Two and four hundred seventy-three thousandths (2.473) hectares (6.11 acres), more or less, out of the north west quarter of the said section nine (9) and eight hundred thirteen thousandths (0.813) of a hectare (2.01 acres), more or less, out of the said south west quarter of section nine (9) required for a railway right-of-way, as shown upon a plan of survey of record in the said Land Titles Office as No. R.Y. 428.
- (3) Sixty-nine thousandths (0.069) of a hectare (0.17 of an acre), more or less, out the said north west quarter of section nine (9) required for a parcel, as shown upon a plan of survey of record in the said Land Titles Office as No. 3715 D.Q.
- (4) Two and one hundred twenty-one thousandths (2.121) hectares (5.24 acres), more or less, out of the said north half of section nine (9) required for a railway right-of-way, as shown upon a plan of survey of record in the said Land Titles Office as No. R.W. 356.
- (5) Two and seven hundred twenty-two thousandths (2.722) hectares (6.73 acres), more or less, out of the said north west quarter of section nine (9) required for a surveyed roadway, as shown upon the said plan No. 841 1151.
- (6) Three hundred sixty-four thousandths (0.364) of a hectare (0.90 of an acre), more or less, out of the said north west quarter of section nine (9) required for an extra railway right-of-way, as shown upon a plan of survey of record in the said Land Titles Office as No. 5896 G.P.
- (7) Two and three hundred ninety-two thousandths (2.392) hectares (5.91 acres), more or less, out of the said north east and south west quarter of section nine (9) required for a roadway, connecting roadway, as shown upon a plan of survey of record in the said Land Titles Office as No. 4876 J.K.
- (8) One and two hundred nine thousandths (1.209) hectares (2.99 acres), more or less, out of the north east quarter of the said section nine (9) required for a parcel, as shown upon a plan of survey of record in the said Land Titles Office as No. 3009 C.F.

- (9) Six hundred nineteen thousandths (0.619) of a hectare (1.53 acres), more or less, out of the said north east quarter of section nine (9) required for a surveyed roadway, as shown upon a plan of survey of record in the said Land Titles Office as No. 2179 E.Z.
  - (10) Six and eight hundred fifteen thousandths (6.815) hectares (16.84 acres), more or less, out of the said north half and south west of section nine (9) required for a roadway, as shown upon a plan of survey of record in the said Land Titles Office as No. 811 0811.
  - (11) Four hundred fifty-seven thousandths (0.457) of a hectare (1.13 acres), more or less, out the said north east quarter of section nine (9) required for a subdivision, as shown upon a plan of survey of record in the said Land Titles Office as No. 801 0101.
  - (12) Eight hundred nine thousandths (0.809) of a hectare (2.00 acres), more or less, out of the said north east quarter of section nine (9) required for a subdivision, as shown upon a plan of survey of record in the said Land Titles Office as No. 831 1120.
  - (13) Three and five hundred forty-one thousandths (3.541) hectares (8.75 acres), more or less, out of the said north east quarter of section nine (9), being more particularly described as follows:

The most easterly six hundred thirty-eight and seventy-eight hundredths (638.78) feet throughout the said quarter section which lies north of the northerly limit of a surveyed roadway, as shown upon a plan of survey of record in the said Land Titles Office as No. 811 0811, and which lies south of a straight line drawn westerly and at right angles to the east boundary of the said quarter section through a point thereon three hundred sixty-nine and thirty-six hundredths (369.36) feet northerly from the iron post "R29" as shown upon the said plan No. 811 0811.
  - (14) Five and one hundred fifty-two thousandths (5.152) hectares (12.73 acres), more or less, out of the west half of the said section sixteen (16) required for a railway right-of-way, as shown upon the said plan No. R.Y. 428.
  - (15) One and one hundred eighty-six thousandths (1.186) hectares (2.93 acres), more or less, out of the north west quarter of the said section seventeen (17) required for a surveyed roadway, as shown upon a plan of survey of record in the said Land Titles Office as No. 6436 B.M.
  - (16) Two and five hundred nine thousandths (2.509) hectares (6.20 acres), more or less, out of the south half of the said section seventeen (17) required for a surveyed roadway, as shown upon the said plan No. 841 1151.
- (B) All that portion of the south east quarter of the said section eighteen (18), required for Block four (4), as shown upon a plan of survey of record in the said Land Titles Office as No. 3128 J.K., containing five and one hundred thirty-six thousandths (5.136) hectares (12.69 acres), more or less.

SAVING AND EXCEPTING:

- (1) One hundred sixty-four thousandths (0.164) of a hectare (0.405 of an acre), more or less, required for a surveyed roadway, as shown upon a plan of survey of record in the said Land Titles Office as No. 841 0570.

The lands herein described contain five hundred ninety-eight and nine hundred nine thousandths (598.909) hectares (1479.885 acres), more or less.
