DINOSAUR PROVINCIAL PARK

FIRSTLY:

All those parcels or tracts of land, situate, lying, and being in the twenty-first (21) township, in the tenth (10) range, west of the fourth (4) meridian, in the Province of Alberta, Canada, and being composed of:

The north half and south west quarter of section six (6), all those portions of section seven (7), which lie on both sides of the Red Deer River, all that portion of the west half of section seventeen (17), which lies generally to the north and west of the left bank of the said River, the north east and south west quarter and all that portion of the south east quarter of section eighteen (18) of the said township, which lies on both sides of the said River.

SECONDLY:

All those parcels or tracts of land, situate, lying, and being in the twentieth (20) township, in the eleventh (11) range, west of the fourth (4) meridian, in the Province of Alberta, Canada, and being composed of:

Sections twenty-five (25) and twenty-six (26) and sections thirty-one (31) to thirty-six (36) inclusive of the said township.

SAVING AND EXCEPTING:

Seven and three hundred twenty-nine thousandths (7.329) hectares (18.11 acres), more or less, required for a surveyed roadway, as shown upon a plan of survey of record in the Land Titles Office at Calgary for the South Alberta Land Registration District as No. 3360 B.Z.

THIRDLY:

All those parcels or tracts of land, situate, lying, and being in the twenty-first (21) township, in the eleventh (11) range, west of the fourth (4) meridian, in the Province of Alberta, Canada, and being composed of:

Sections four (4), five (5) and six (6), the south east quarter of section ten (10), the south half of section eleven (11), the north west quarter of section sixteen (16), the north east and south west quarter of section seventeen (17), all those portions of sections one (1), three (3), seven (7), eight (8), nine (9), twelve (12), the west halves of sections two (2) and the said section ten (10) and the south half of the said section sixteen (16), which lie on both sides of the Red Deer River, all that portion of the south east quarter of the said section two (2) which lies generally to the south of the right bank of the said River, all that portion of the south east quarter of the said section seventeen (17) which lies generally to the north of the left bank of the said River and Islands No. One (1) to Ten (10) inclusive of the said township.

SAVING AND EXCEPTING:

Three and nine hundred fifty-eight thousandths (3.958) hectares (9.78 acres), more or less, required for a surveyed roadway, as shown upon the said plan No. 3360 B.Z.

FOURTHLY:

All those parcels or tracts of land, situate, lying, and being in the twentieth (20) township, in the twelfth (12) range, west of the fourth (4) meridian, in the Province of Alberta, Canada, and being composed of:

The north half of section twenty-six (26) and sections thirty-five (35) and thirty-six (36) of the said township.

FIFTHLY:

All those parcels or tracts of land, situate, lying, and being in the twenty-first (21) township, in the twelfth (12) range, west of the fourth (4) meridian, in the Province of Alberta, Canada, and being composed of:

- (A) The north east quarter of legal subdivision eight (8) and the south east quarter of legal subdivision nine (9) of section one (1), the east half of section fourteen (14), the north west quarter of section twenty-six (26), section twenty-seven (27), the south half and north west quarter of section thirty-four (34), all those portions of the north half of section eleven (11), the north west quarter of the said section fourteen (14), the north east quarters of sections fifteen (15) and twenty-one (21) and all those portions of sections twelve (12), twenty-two (22), twenty-eight (28) and thirty-three (33) which lie generally to the north and east of the left bank of the Red Deer River and Islands No. one (1), two (2) and three (3) of the said township.
- (B) All those portions of the north half of the said section one (1) and the south half of the said section twelve (12) of the said township, required for Block one (1), as shown upon a plan of survey of record in the said Land Titles Office as No. 841 0954.

SAVING AND EXCEPTING:

- (1) Fifty-three thousandths (0.053) of a hectare (0.13 of an acre), more or less, out of the north west quarter of the said section twelve (12), required for a metre station right-of-way, as shown upon a plan of survey of record in the said Land Titles Office as No. 4803 J.K.
- (2) Four and four hundred ninety-two thousandths (4.492) hectares (11.10 acres), more or less, required for a surveyed roadway, as shown upon a plan of survey of record in the said Land Titles Office as No. 731296.

SIXTHLY:

All that parcel or tract of land, situate, lying and being in the twenty-second (22) township, in the twelfth (12) range, west of the fourth (4) meridian, the Province of Alberta, Canada, and being composed of:

All that portion of the south west quarter of section four (4) of the said township required for a campsite, as shown upon a plan of survey of record in the said Land Titles Office as No. 961 0864.

The lands herein described contain eight thousand eighty-five and nine hundred fifty-five thousandths (8,085.955) hectares (19,980.12 acres), more or less.
