| 8 | All that portion of the south east quarter of section 10 of the said township, required for a tower site (MLL780113), being more particularly described as follows: |

Commencing at the south west corner of Parcel "D" as shown on plan No. 31 KS (1276 GEN); thence northerly and along the westerly boundary of the said Parcel "D" a distance of 122.29 metres (401.20 feet), more or less, to its intersection with the southerly boundary of Parcel "E" as shown upon the said plan No. 31 KS; thence north westerly along the south westerly boundary of the said Parcel "E" a distance of 122.29 metres (401.20 feet); thence southerly and parallel to the said westerly boundary of Parcel "D" a distance of 122.29 metres (401.20 feet); thence south easterly and parallel to the said south westerly boundary of Parcel "E" to the point of commencement.

- 9 All that portion of the south east quarter of section 10 of the said township, required for a radio repeater tower site (MLL780089), being more particularly described as follows:

Commencing at the south east corner of plan No. 2891 JY (1807 GEN); thence southerly measured along the east boundary of the said quarter section a distance of 45.72 metres (150.0 feet); thence westerly at right angles to the last described course a distance of 45.72 metres (150.0 feet); thence northerly and parallel to the said east boundary a distance of 45.72 metres (150.0 feet), more or less; to a point on the south boundary of the said plan No. 2891 JY; thence westerly and along the south boundary of the said plan to the point of commencement.

- 10 All that portion of the east half of section 10 of the said township, required for a radio tower site (MLL 2981), being more particularly described as follows:

Commencing at the north east corner of plan No. 2891 JY (1807 GEN); thence westerly along the northerly boundary of the said plan No. 2891 JY, and its projection westerly in a straight line, a distance of 121.92 metres (400.00 feet); thence northerly at right angles to the last described course a distance of 121.92 metres (400.00 feet); thence easterly at right angles to the last described course a distance of 121.92 metres (400.00 feet), more or less, to a point on the easterly boundary of the north east quarter of the said section 10; thence southerly along the said easterly boundary, and continuing southerly along the easterly boundary

of the south east quarter of the said section 10, a distance of 121.92 metres (400.00 feet), more or less, to the point of commencement.
